RLH 1955

Section 46-1

There shall be a board of health for the Territory....consisting of eleven members (including the president), of whom ten shall be appointive members and one shall be the attorney general of the Territory, ex-officio. At least two but not more than three of the appointive members shall be persons who are licensed to practice as doctors of medicine in the Territory. At least one but not more than two of the appointive members shall be persons who are licensed to practice as dentists or dental surgeons in the Territory. At least three of the appointive members shall be residents of a county other than the city and county of Honolulu, that is, one from each of the counties of Hawaii, Kauai and Maui. The president shall be a person who (a) has been or is eligible

to be certified by the American Board of Preventive Medicine and Public Health, Incorporated, or (b) is (1) licensed to practice as a doctor of medicine or osteopathy in the Territory and has successfully completed at least one year of graduate study leading to a degree in public health, and (2) has had, during the ten years next preceding his consideration for appointment, at least six years of practical experience in public health work, including supervision or administration of such work, in communities of not less than 50,000 population, or in the United States Public Health Service as a commissioned medical officer. The president and other appointive members shall be appointed for terms of 4 years, and may be removed, by the governor in the manner prescribed by section 80 of the Organic Act....

The president shall be the presiding officer of the board. During the temporary absence from the Territory or the illness of the president, the governor shall designate one of the members of the board as acting president. In case of the absence from any meeting of the president or an acting president, any member may be chosen by the board to preside at such meeting.
