Replying to his communication of Jan. 10th. wherein he says that he had been assessed \$10.- per acre for Sugar lands, & \$3,300.- for the cane planted upon said lands & that he will be assessed in 1877 at the rate of \$75.- per acre for the same cane, thereby becoming liable to double taxation, &c That the system of valuation & assessment will be revised before the assessment of next year, as to make it just to the Govt & not unjust to the Tax-Payers, so that no citizen shall be oppressed in either person or property.
